THIS INDENTURE, Made and entered into this 20th day of January, one thousand nine hundred and six

and W. P. Phillips of Winita Indian Territory part ies of the second part;

WITNESSETH, That that the said part 4 of the first part, for and in consideration of the sum of Five Hundred and 00/100
(500.00) DOLLARS, in hand paid, the receipt of which is hereby acknowledged,

do so hereby grant, bargain, sell, convey and confirm unto the said part ies of the second part the following described real estate and premises situated in the Cherokee
Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit: The Northeast Quarter of the Northeast
Quarter of the Southeast Quarter of Section Six (6) Township Twenty (20) North
Range Thirteen (13) East; The Northwest Quarter of the Northwest Quarter of
the Northwest Quarter of Section Five (5) Township 21 North Range 13
East; The East Half of the Northeast Quarter of the Northwest Quarter and the
Southeast Quarter of the Southeast Quarter of the Northwest Quarter of Sec. 6 Township 21 N. R. 13 E.
together with all the improvements thereon, and the appurtenances and immunities thereon or in any wise appertaining thereto

To have and to hold the aforegranted premises to the said T. M. Buffington, L. W. Buffington and W. P. Phillips
and their heirs assigns, in fee simple forever; and I the said Cora Vann
for myself and my heirs, executors and administrators do covenant with the said grantee
and their heirs, successors and assigns, that I am lawfully seized in fee of the aforegranted premises; that
they are free from all incumbrance; that I have good right to sell and convey the same to said
grantee aforesaid; and that I will and my successors, heirs, executors and administrators shall warrant and de-
fend the same to the said grantee
and their heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, wife of said for and in consideration of the said sum of money, do hereby re-
lease and relinquish unto the said part ies of the second part all my right of dower and homestead in and to the said lands.
