

## GENERAL WARRANTY DEED

WITH REINFORCEMENT OF POWER

THIS INDENTURE, Made and entered into this 9th day of August, one thousand nine hundred and seven, by and between Henrietta Sarty, formerly Henrietta Berryhill and Jasper Sarty, her husband, both of Coweta, I. T., of the first part; and Western Investment Company of Coweta, Indian Territory, of the second part;

WITNESSETH, That that the said part, of the first part, for and in consideration of the sum of,

One Thousand 1000, DOLLARS, in hand paid, the receipt of which is hereby acknowledged,

do hereby grant, bargain, sell, convey and confirm unto the said part, of the second part the following described real estate and premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to wit, The West Half (½) of the south west quarter (¼) of section one (1) Township seventeen (17) North and Range Twenty (20) East of the Indian Base and Meridian in Indian Territory containing eighty (80) acres more or less of the allotment of Henrietta Sarty, formerly Henrietta Berryhill

together with all the improvements thereon, and the appurtenances and immunities thereon belonging or in any wise appertaining thereto.

To have and to hold the aforesigned premises to the said Western Investment Company and its heirs and successors, in fee simple forever; and they the said Henrietta Sarty and Jasper Sarty for themselves and their heirs, executors and administrators do covenant with the said Western Investment Company and its heirs, successors and assigns, that they are lawfully seized in fee of the aforesigned premises; that they are free from all incumbrances; that they have good right to sell and convey the same to said Western Investment Company as aforesaid; and that they will and their successors, heirs, executors and administrators shall warrant and defend the same to the said Western Investment Company and its heirs, successors and assigns forever against the lawful claims and demands of all persons.

And, wife of said, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part, of the second part all my right of dower and homestead in and to the said lands.
