

GENERAL WARRANTY DEED

WITNESS RELINQUISHMENT OF DOWER

THIS INDENTURE, Made and entered into this 13 day of August, one thousand nine hundred and twenty two, by and between Caesar Simon, brother and Mandy Simon, wife and of Lorraine Simon, part of the first part, and Commercial Land Company, corporation, of Muskogee, Okla., part of the second part;

WITNESSETH, That that the said part of the first part, for and in consideration of the sum of One Dollar, and other valuable consideration do hereby grant, bargain, sell, convey and confirm unto the said part of the second part the following described real estate and premises situated in the

Muskogee or Creek Nation, and within the limits of the Indian Territory, to wit: All their right, title and interest in and to the West half (W $\frac{1}{2}$) of South West Quarter S. W. $\frac{1}{4}$, and the North East Quarter (N. E. $\frac{1}{4}$) of South West Quarter S. W. $\frac{1}{4}$ of Section Eleven (11), Township Eighteen (18) North Range Thirteen (13) East and containing one hundred and twenty (120) acres, more or less, being the allotment exclusive of homestead, of their deceased

To have and to hold the aforesigned premises to the said Commercial land company and its heirs and successors, in fee simple forever; and we the said Caesar Simon and Mandy Simon for ourselves and our heirs, executors and administrators do covenant with the said Commercial land company and its heirs, successors and assigns, that we are lawfully seized in fee of the aforesigned premises; that they are free from all incumbrance

as aforesaid; and that we will and our successors, heirs, executors and administrators shall warrant and defend the same to the said Commercial land company and its heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, [redacted] of [redacted] for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to the said lands.
