MORTGAGE OF REAL PROPERTY.

THIS INDENTURE, Made this 13th day of November, A. D., 1906, between Bessie B. Logsdon of Indian Territory and E. M. Logsdon her husband, his wife and George Wallach witnesseth, that

WHEREAS, the said Bessie B. Logsdon is justly indebted to the said George Wallach in the sum of Seven Hundred DOLLARS (\$ 700.00) which is evidence by one certain promissory note of even date herewith, to-wit:

One note due May 13, 1906, for \$ 700.00; one note due 1906, for \$ 190; and one note due 1906, for \$ 190.

NOW, THEREFORE, the said Bessie B. Logsdon and E. M. Logsdon her husband his wife, for the better securing the payment of the money aforesaid, with interest thereon according to the tenor and effect of said note above mentioned, do hereby grant, bargain, sell and convey unto the said George Wallach, his heirs and assigns forever, the following described real estate, to-wit:

all of the North East Quarter of the North East Quarter of Section Thirty in Township Twenty Range Twenty (N.E. 1/4 N.E. 1/4) Sect 30, T. 20, R. 14) Being Forty acres more or less according to U.S. Survey

with all the improvements thereon at the present time, or that hereafter may be placed thereon, together with all the privileges and appurtenances thereto belonging.

TO HAVE AND TO HOLD the above granted, bargained, and described premises unto the said George Wallach, his heirs and assigns and unto their own proper use, benefit and behoof forever.

AND WHEREAS, For the further security of said indebtedness, the said part of the first part covenant and agree with the said part of the second part, to keep the improvements on the said property at all times in a state of good repair and constantly insured for the benefit of the said part of the second part, his heirs and assigns in one or more insurance companies satisfactory to the said part of the second part, against fire, lightning or tornadoes. Should the part of the first part make default in the performance of any of these stipulations, the said part of the second part may immediately perform and discharge the same, and all accounts so expended by the said part of the second part, heirs or assigns, in paying said taxes, insurance premiums, liens or special assessments or in protecting said title, or making said repairs, shall become a debt due in addition to the indebtedness aforesaid, and secured in like manner by this mortgage, and shall bear interest from the time of the payment thereof at the rate of eight per cent per annum payable on demand.

And for the consideration aforesaid, and for divers other good and valuable considerations, I, E. M. Logsdon Husband of said Bessie B. Logsdon do hereby release and quit-claim unto the said George Wallach, his heirs and assigns, all my right, claim or possibility of dower in and out of the aforescribed premises.

CONDITIONED, However, that if the said Bessie B. Logsdon her heirs, executors, or administrators, shall well and truly pay or cause to be paid to the said George Wallach, his executors, administrators, or assigns, the aforesaid sum of money, with interest thereon, according to the tenor of said note, then this instrument shall be void otherwise to remain in full force and effect.
