OIL AND GAS LEASE

COMPARED

AGREEMENT, Made and entered into the 26th day of May, 1922 by and between G. W. Lemons as Guardian of Wallace E. Lemons, a Minor, Party of the first part, hereinafter called lessor (whether one or more) and Bert Pitts, party of the second part, hereinafter called lessee.

WITNESSETH, That the said lessor for and in consideration of Thirty DOLLARS cash in hand paid, receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does (grant, demise, lease and let) unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, and of building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa State of Oklahoma, described as follows, to-wit:

The North Half of the South-east quarter of the south-west quarter;

and the South-west Quarter of the North-east Quarter of the South-east Quarter of Section 6 Township 22 N. Range 14 E. and containing 30 acres, more or less.

It is agreed that this lease shall remain in force for a term during the minority from this date and as long of said minor, thereafter as oil or gas or either of them, is produced from said land by the lessee.

In consideration of the premises the said lessee covenants and agrees .

1st . To deliver to the credit of lessor, free of cost, in pipe line to which it
