

Oil and Gas Mining lease, dated Oct. 6, 1915, executed by Jennie E. Brown and Samuel W. Brown to Mannford Oil and Gas Company, recorded in Book 180 at Page 71, of the office of Tulsa County Clerk, Oklahoma, which said oil and gas mining lease has been duly assigned to first party hereto, and covers the following described property, located in said Tulsa County, Oklahoma, to wit:

The Northwest Quarter (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Twenty-two (22) Township Eighteen (18) North, Range Twelve (12) East.

Oil and Gas Mining Lease executed by Reese Harvison on May 20, 1915 to F. G. The East half (E $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirty-two (32), Township Eighteen (18) North, Range Twelve (12) East, and The North Half of the Northeast Quarter (NE $\frac{1}{4}$) of Section Six (6) Township Seventeen (17) North, Range Twelve (12) East.
