## RELEASE OF OIL AND GAS MINING LEASE

KNOW ALL MEN BY THESE PRESENTS: That, Whereas, heretofore, to-wit on the 10th day of October 1910 George C. Probst, his heirs and assigns, all the right, title and interest which we may have acquired under and by virtue of said lease above described.
