That the said party of the second part is here hereby authorize and permitted to construct, connect with and make use of the newer in SEAR DISTRICT NO. 80 of the City of Tulsa, upon the said party of the second part paying the entire cost of such sewer construction, connection and use, and in addition paying to the said City of Tulsa, the sum of Five (55) per centum of the cost of such construction, connections and use, as an engineering fee for the supervision of such construction, connection and use.
