Schuermeyer and wife Mabel Shuermeyer of Tulsa, Oklahoma party of the first part, hereinafter called lessor(whether one or more), and Kingwood Oil Company; and A. D. Adcock and Joe McClelland and Jess F.McClelland, partners as ADCOCK & McCLELLAND/ party of the second part, hereinafter called lessee.

WITNESSETH, That the said lessor, for and in consideration of One and no 100

DOLLARS, cash in hand paid, receipt of which is hereby acknowledged and of the covenants and agreements hereinafter contained on the part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee, for the sole and only purpose of mining and operating for oil and gas, and laying pipe lines, and building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa , State of Oklahoma, described as follows.towit:

The Southwest Quarter of Section Seventeen (17) Township Sixteen (16) North and Range Fourteen(14) Eastcontaining 160 acres, more or less.

It is agreed that this lease shall remain in force for a term of Five years from this date, and as long thereafter as oil or gas, or either of them, is produced from said land by the lessee.
