ASSIGNMENT OF OIL AND GAS LEASE

 valuable considerations), the receipt of which is hereby acknowledged, the undersigned,
 the present owner of the said lease and all rights thereunder or incident thereto, does
 hereby bargain, sell, transfer, assign and convey unto Benjamin W. Hasenjaeger, an un-
 divided one, two-hundredth interest of his right, title and interest of the original
 lessee and present owner in and to the said lease and rights thereunder in so far as
 it covers the Northeast 1/4 of the Northeast 1/4 and West 1/2 of the Northeast 1/4 of
 Section 21 Township 19 North Range 13 East. The portions being assigned containing 120
 acres more or less according to the Government Survey thereof, together with all person-
 al property used or obtained in connection therewith to ----- and -----heirs,
 successors and assigns.

And for the same consideration, the undersigned for himself and his heirs,
