STATE OF OKLAHOMA, SS. ARTICLES OF SEPARATION.  
COUNTY OF TULSA.

THIS AGREEMENT, made this the 21st day of June 1922, by and between G. E. Jackman party of the first part and Mable Jackman party of the second part, husband and wife, both of Sperry, Oklahoma:
