C. E. Gilbert, also known as Emery Gilbert, of full age, being first duly sworn, on oath says: That he is the grantee named in certain conveyances by R. A. Haver, Trustee, to Emery Gilbert, conveying lots three (3), four (4) and five (5) in Block one (1); and lots thirteen (13), fourteen (14), fifteen (15), sixteen (16), seventeen (17) and eighteen (18) in Block two (2) in Bullette Addition of Tulsa, Oklahoma, as per plat of said addition on record in the Register of Deeds' office, Tulsa County. That deponent is also the C. E. Gilbert who brought action for divorce from Ethel Gilbert, his former wife, in the District Court of Tulsa, County, numbered 11554 in the files of said Court, and obtained a decree of divorce in said action on the 12th day of May, 1920. That deponent was one of the defendants in an action in the District Court of Tulsa County, entitled State ex rel. etc., vs. Tom Wortham et al., numbered 10908 in the files of said Court, and May 20, 1920, deponent paid \$350.00 in full satisfaction and discharge of the judgment therein rendered against deponent on the 29th day of March, 1920.

Deponent further says that he is not the C. E. Gilbert named as a defendant in cause No. 8274 in the District Court of Tulsa County, nor was deponent the owner and mortgagor of lots 24, 25 and 26, of Block 3 in the Park Hill Addition to the City of Tulsa which said action involved, the same having been brought to foreclose a mortgage given by one C. E. Gilbert, but not by this deponent. Deponent further says that he was never the owner of lots 24 and 25 in Block 17, East Addition, New Tanahar, nor was deponent the C. E. Gilbert named as defendant in cause No. 5115 in the Superior Court of Tulsa County, in which an attachment was levied against said last described real estate and in which default judgment was rendered in favor of J. T. Kendrick, plaintiff, vs. one C. E. Gilbert, defendant, on the 25th day of April, 1920. That deponent was not the defendant named in said action brought by J. T. Kendrick against one C. E. Gilbert, and that the judgments recovered against said C. E. Gilbert in District Court cause #8274 and Superior Court cause #5115, were not against this deponent and are not a lien against deponent's property above described.
