

This Indenture, Made this 15th day of June A. D. 1922, between Berry-Hart Company a corporation, organized under the laws of the State of Oklahoma of Tulsa County, of Tulsa State of Uklahoma party of the first part, and Joe Robertson , party of the second part.

WITNESSETH, That in consideration of the sum of Three hundred fifty (\$350.00) and no/100 DOLLARS, the receipt; whereof is hereby acknowledged, the said party of the first part does, by these presents, grant, bargain, sell and convey unto said party of second part, his heirs, executors or administrators, all of the following described real estate, situated in the County of Tulsa, State of Uklehoma, to-wit:

Lot Ten (10), Block Two (2), Sunnybrook Addition to the City of Tulsa County of Tulsa Oklahoma, according to the duly recorded plat thereof. TO HAVE AND TO HOLD THESAME, together with all and singular the tenements, hereditants, and appurtenances thereto belonging or in any wise appertaining forever.
