AGREEMENT

THIS INDENTURE, made and entered into this 29th day of March 1922, by and between HOGUE OIL & REFINING CORPORATION, party of the first part and Arthur S. Hogue, F. L. Buskey Jr. R. A. Hogue, Leander Bouyea, F. J. Columbe, Edward Bernard and J. O. Trombley all of Plattsburg, Clinton County, New York, parties of the second part,

WITNESSETH:
