FINDINGS OF FACT AND CONCLUSIONS OF LAW

The Court having heard the testimony and having taken the above case under advisement until this the 22nd day of November 1919, makes the following findings of facts and conclusions of law.

First: The court finds that due and legal service has been had upon all parties interested and that the Court has jurisdiction of all parties interested and of the subject matter involved herein.

Second: The Court finds that the testatrix, Jennie M. Cook, departed this life on the first day of March, 1919, in Tulsa County, Oklahoma, that at the date of her death, she was a resident of Tulsa County Oklahoma; and that she was possessed of the following described property at the date of her death;

Lot Nine (9) Block Three (3), Hodge Addition to the city of Tulsa, Oklahoma, All of Lot Ten (10) Block Three (3) Hodge Addition to the city of Tulsa, Oklahoma; 6 42/100 acres University Addition to the City of Ottawa, Kansas.

Third; The Court further finds that on the third day of August, 1917, said testatrix, Jennie M. Cook, executed her last will and testament, which said will had never been revoked or set aside at the date of her death, giving and devising certain of her property to Irving V. Jones and W. W. Blankenship and giving and bequeathing certain of her property to Ers. Lovina Cook, Mrs. Nellie Cook Richards, Mrs. Myra Cook Gurler, George W. Cook Elva Mary Cook Thomas and Stella Marsh Cook Kasey.

Fourth: The Court further finds that at the date of the execution of said will the testatrix, Jennie M. Cook, was over the age of Eighteen Years, of sound and disposing mind and memory, and the execution of said will was not procured to be made by duress, menace, fraud or undue influence; that said will was the free and voluntary act and deed of said testatrix, the said Jennie M. Cook, for the purposes therein set forth; and that said will was in all respects executed in conformity to the laws of the State of Oklahoma.

Fifth: The Court finds that said will should be and is therefore by the court admitted to probate as the last will and testament of the testatrix, Jennie M. Cook, and that letters testamentary with a copy of said will annexed are directed to issue to the executor mentioned in said will, namely, W. W. Blankenship.
