EXCEPT General and Special taxes for the year 1922 and all subsequent years, and it is further agreed between the parties hereto that this lot is sold for residence purposes only and no dwelling shall be erected to cost less than Forty-Five Hundred (\$4500.00) Dollars, and no part of which shall be nearer the front lot line than Thirty (30) Feet, and that said Corporation will WARRANT and FOREVER DEFEND The same unto said party of the second part his heirs, executors or administrators, against said party of the first part, their successors or assigns, and all and every person or persons whomsoever , lawfully claiming or to claim the same.
