Complainant in said Original Bill to said Answer and the testimony of witnesses sworn and examined in open Court and the Court having heard the arguments of counsel and being fully advised in the premises on consideration thereof, finds that all the material facts alleged in said Original Bill are true; that the said Complainant in said Original Bill, is an actual resident of the said County of maxewell and State aforesaid and has been a resident of the State of Illinnis, for more than two (2) years last past; and that on the 2nd day of February 1893 the said Complainant in said Original Bill was lawfully married to the said Catherine A. Moehl, the Defendant in said Bill and that he continued to live with her as her husband from the time of said marriage until June 1st, 1918, at which time said parties were actual residents of the State of mansas and had been for some seven (7) or eight (8) years prior thereto; that at the time mentioned herein as aforesaid on, towit June 1st, 1918, and while the said parties were residents of the City of Wichita, in the State of Mansas, the Defendant, Catherine A.Moehl, without cause, abandoned and deserted the home of the Complainant herein and continued in such desertion from said time to the filing of the Bill hereto.

Court further finds that during the time the said complainant, Adam J. Moehl co-habited with the Defendant, Catherine A. Moehl, as her husband, he faithfully performed and discharged his marriage duties and obligations and demeaned himself towards the Defendant and provided for her as best his condition in life afforded.

The court further finds that as the issue of said marriage there was one child, Arthur S. Moehl, born to them, which said child is now deceased.

The Court further finds that the name of the parties hereto is variously spelled: "Moehl," "Mahle," and that the correct spelling of the name is as the same is spelled by the complainant in his sill herein, namely: "Moehl."

The Court further finds that it has jurisdiction, both of the parties and subject matter hereof and that said parties were legally married on or about the 2nd day of rebruary, A. D.1895, in Tazewell county, Illinois, and further finds the equities of said cause are with the complainant herein and that the facts alleged in the original Bill herein, are true.

The court further finds that the said catherine A. Moehl, the Defendant in said Original Bill, wholly regardless of her marriage duties, covenants and obligations, afterwards on June 1st, 1918, lawfully deserted and absented herself from the said Adam J. Moehl, complainant in said criginal Bill, without any reasonable cause or excuse and continued in such desertion for the space of two (2) years and upwards, that she has persisted in such desertion and yet persists therein and continues to absent herself from the said Adam J. Moehl, the complainant in said criginal Bill.

The court further finds that the complainant is the owner and possessed in fee simple of certain real estate located in the County of Tulsa and the State of Oklahoma and more particularly described as:

The South 20 acres of Lot 1; North Half of the South East Quarter of the North East Quarter and the South West Quarter of the South East Quarter of the North East Quarter of Section I.T. 22 North, Range 12, East, containing 50 acres more or less.

The Court further finds that a stipulation was made and entered into by and between the said Complainant and Defendant herein, in settlement of all property rights, alimony, solicitors fees and suit money, wherein it is agreed by and between the parties that said Complainant, Adam J. Moehl, is to convey by Quit Claim Deed, all right and interest that he may have to the South Twenty (20) acres of Lot One (1) situated in Section One, (1), Township Twenty-two (22) North, Range Twelve (18), Tulsa County
