# A S S I G N M E N T

of

OIL AND GAS MINING LEASES

KNOW ALL MEN BY THESE PRESENTS: That THE AKIN OIL COMPANY, a corporation under the laws of the State of Oklahoma, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration to it in hand paid by THE KEENER OIL & GAS COMPANY, a corporation under the laws of the State of Ohio, the receipt of which is hereby acknowledged, does hereby grant, sell, assign, transfer, set over and convey unto THE KEENER OIL & GAS COMPANY, its successors and assigns, the following described leases for oil and gas purposes and the interests therein specified and all the right, title and interest in and to said leases for oil and gas purposes and the rights and titles therein given, granted and created as follows, to-wit:

## FIRST LEASE ( Jennie Samuels)

The entire Working Interest in and to that certain oil and gas mining lease made and entered into on the 18th day of November, 1915, by and between W. D. Cornelius and Minnie L. Cornelius, husband and wife, as lessors, and L. H. Beosche, as lessee, covering the following described land situate in Tulsa County, Oklahoma, to-wit:
