GENERAL POWER OF ATTORNEY INTERNAL REVENUE

KNOW ALL MEN BY THESE PRESENTS:

THAT I, LIONEL E. Z. AARONSON, of Tulsa, Oklahoma, also known as L. E. Z. AARONSON, have made, constituted and appointed and by these presents do make, constitute and appoint ALFRED E. AARONSON, also known as A. E. AARONSON, as my true and lawful attorney, for me and in my name, place and stead and for my use and benefit, to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, interests, dividends, annuities and demands whatsoever, as are now or which shall hereafter become due, owing, payable or belonging to me, and have, use and take all lawful ways and means, in my name or otherwise, for the recovery thereof by legal process or otherwise, and to compromise and agree for the same and acquittances or other sufficient discharges for the same, for me and in my name to make, seal and deliver; to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments and accept the possession of all lands and all deeds and other assurances in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments upon such terms and conditions and under such conveyances as he shall deem fit. Also to bargain and agree for, buy, sell, mortgage, hypothecate, and in any and every way and manner to deal in and with goods, wares, merchandise, choses in action and other property, in possession or in action, and to make, do and transact all and every kind of business of whatever nature and kind whatsoever; and also for me and in my name and as my act and deed to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements, mortgages, hypothecations, bills of sale, bills, bonds, notes, receipts, evidences of debt, releases and satisfactions of mortgages, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises, And I authorize my said attorney one or more attorneys
