This agreement, executed in triplicate, this 6th, day of February, 1922, by and between C. E. Woods, of Tulsa, Oklahoma, party of the first part, and Irell M. Smith and Iva Smith, parties of the second part.

Witnesseth, that for and in consideration of the sum of \$800.00, to be paid as hereinafter provided. The party of the first part does hereby sell and convey to parties of the second part the following described premises, to wit:

The North Half (1/2) of the South Seventy-five (75) feet of Lots twenty-four (24) and Twenty-five (25) in Block Two (2) in Washington Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the Recorded Plat thereof.

The parties of the second part have this day paid in cash the sum of \$350.00, the receipt of which is hereby acknowledged. Balance of said consideration or \$450.00, payable at the rate of \$25.00, per month, same being evidenced by 18 certain promissory notes of this date. The first of said series of notes being due April 1st, 1922, and one due upon the first day of each and every month thereafter until all of said series are paid. It is agreed that said notes shall bear interest at the rate of 8% per annum, after
