dated May 1, 1921, its successors and heirs forever, all of the right, title and interest of the Company in and to said six hundred (600) tank cars hereinbefore described.

But in trust, nevertheless, for the equal and proportionate benefit and credit of all of the holders of the bonds and interest coupons issued and to be issued under said mortgage dated May 1, 1921, without any preference, distinction or priority as to lien or otherwise of any bond or bonds over others by reason of the difference in time of actual issue, sale or negotiation thereof, but so that each and every bond issued under said mortgage dated May 1, 1921 shall have the same lien, right and privilege and so that the principal and interest of every such bond shall, subject to the terms hereof, be equally and proportionately secured hereby, as if each and all had been made, executed, delivered, sold and negotiated simultaneously, and in all respects subject to all of the terms, provisions, and conditions of said first mortgage dated May 1, 1921,

It is the intent and purpose of this instrument that it shall operate as a supplemental mortgage, having the effect to bring under the terms of said mortgage of May 1, 1921 all right, title and interest of said Constantin Refining Company in and to the tank cars hereinbefore described under and by virtue of said lease and car trust agreement dated April 1, 1922.
