ASSIGNMENT OF OIL AND GAS LEASE

WHEREAS, On the 23rd day of February 1922, a certain oil and gas mining lease was made and entered into by and between J. A. CLINE and IDA CLINE Lessor and FRANK SPARKS Lessee covering the following described land in the county of Tulsa and State of Oklahoma to-wit:

Lots 2, 6, 7, and 10 and all of the South half of the South half of the Southeast Quarter of the Northeast Quarter of Section 1; Twp. 18 North; Range 12 East containing 100 acres more or less, according to government survey thereof, reserving unto lessors all oil, gas and other mineral rights in and to the riparian lands between the westerly line of the lands herein described and the thread of the Arkansas River.

NOW, WHEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, does hereby bargain, sell, transfer assign and convey unto ALICE MARSTON 1/48th interest of the right, title, and interest of the original lessee and present owner in and to said lease and rights thereunder insofar as it covers the Real estate together with all personal property used or obtained in connection therewith to her and her heirs, successors and assigns.

And for the same consideration, the undersigned for him and his heirs, successors and representatives, does covenant with the said assignee, her heirs, successors or assigns that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that the said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
