WITNESSETH, that said part--- of the first part in consideration of the sum of Four Hundred Thirty Dollars, the receipt whereof is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto said part--- of the second part, its successors and assigns, all the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit:
