Said first part 1st hereby covenant \_\_\_\_\_ that they are the owner 8 in fee simple of said premises and that they are free and clear of all incumbrances \_\_\_\_\_

That they have \_\_\_\_\_ good right and authority to convey and encumber the same, and \_\_\_\_\_ will warrant and defend the same against the lawful claims of all persons whomsoever. Said first part 1st agree \_\_\_\_\_ to insure the buildings on said premises in the sum of \$ 2,000.00 for the benefit of the mortgagee and maintain such insurance during the existence of this mortgage.
