THIS INDENTURE, Made this 4th day of June A. D. 1923, between
H. W. Hoffman and Ada E. Hoffman,
of Tulsa County, in the State of Oklahoma, part 1st of the first part, and
E. O. Decker,
of Tulsa County, part 2nd of the second part:
WITNESSETH, That said part 1st of the first part, in consideration of the sum of
Fifteen hundred and no/100 Dollars,
the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto said part 2nd of the second part, their heirs and assigns, all the following described real estate situated in Tulsa County and State of Oklahoma, to-wit:

"This is second mortgage, first mortgage is \$4000."

All of Lot (4) Four in Hillcrest Park Addition to the city of Tulsa, Tulsa County, Okla. according to the recorded plat thereof.

I hereby certify that I received \$ 60.00 not less than \$29.34 therefor in payment of mortgage tax on the within mortgage.

To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining forever.

This conveyance is intended as a mortgage to secure the payment of one promissory note of even date herewith. One for \$ 1500. due fifty dollars on the 4th day of each month with interest, 192 at the rate of 8% per annum made to E. O. Decker

or order, payable at Tulsa monthly with 8% per cent interest per annum, payable semi-annually and signed by H. W. Hoffman and Ada E. Hoffman, his wife. Said first part 1st hereby covenant that they are owner. S. in fee simple of said premises and that they are free and clear of all incumbrances except first Mtg. \$4000.

That they have good right and authority to convey and encumber the same, and they will warrant and defend the same against the lawful claims of all persons whomsoever. Said first part 1st agree to insure the buildings on said premises in the sum of \$ 5500 for the benefit of the mortgagee and maintain such insurance during the existence of this mortgage. Said first part 1st agree to pay all taxes and assessments lawfully assessed on said premises before delinquent.

Said first part 2nd further expressly agree that in case of foreclosure of this mortgage, and as often as any proceeding shall be taken to foreclose same as herein provided, the mortgagor will pay to the said mortgagee One hundred fifty Dollars as attorney's or solicitor's fees therefor, in addition to all other statutory fees; said fee to be due and payable upon the filing of the petition for foreclosure and the same shall be a further charge and lien upon said premises described in this mortgage, and the amount thereon shall be recovered in said foreclosure suit and included in any judgment or decree rendered in action as aforesaid, and collected, and the lien thereof enforced in the same manner as the principal debt hereby secured.

Now if said first part 1st shall pay or cause to be paid to said second part 2nd this heirs or assigns said sum of money in the above described note mentioned, together with the interest thereon according to the terms and tenor of said note, and shall make and maintain such insurance and pay such taxes and assessments then these presents shall be wholly discharged and void, otherwise shall remain in full force and effect. If said insurance is not effected and maintained, or if any and all taxes and assessments which are or may be levied and assessed lawfully against said premises, or any part thereof, are not paid before delinquent, then the mortgagee may effect such insurance or pay such taxes and assessments and shall be allowed interest thereon at the rate of per cent per annum, until paid, and this mortgage shall stand as security for all such payments; and if said sum or sums of money or any part thereof is not paid when due, or if such insurance is not effected and maintained or any taxes or assessments are not paid before delinquent, the holder of said note, and this mortgage may elect to declare the whole sum or sums and interest thereon due and payable at once and proceed to collect said debt including attorney's fees, and to foreclose this mortgage, and shall become entitled to possession of said premises.

Said first part 1st waive notice of election to declare the whole debt due as above and also the benefit to stay, valuation or appraisal laws. IN WITNESS WHEREOF, said part 1st of the first part ha. V. hereunto set. their hand. S. the day and year first above written.
