Said first part 1st hereby covenant _____ that they are _____ owner S. in fee simple of said premises and that they are free and clear of all incumbrances except 1st mortgage to Home Building & Loan Association of Tulsa Amount \$800.00

That they have _____ good right and authority to convey and encumber the same, and they will warrant and defend the same against the lawful claims of all persons whomsoever. Said first part 1st agree _____ to insure the buildings on said premises in the sum of \$ 150.00 for the benefit of the mortgagee and maintain such insurance during the existence of this mortgage. Said first part 1st agree _____ to pay all taxes and assessments lawfully assessed on said premises before delinquent.
