

Assignment of Oil and Gas Lease No. 409

WHEREAS, On the 30th day of July 1922, a certain oil and gas mining lease was made and entered into by and between Florence D. Ballou, Elmer Leroy Loyd, and Oness Delore Loyd, Lessor, and William G. Weber, and David MacLean, an undivided one forty-eighth (1/48) interest each, and to Louis Wise an undivided one twenty-fourth (1/24) interest each, in and to the said lease and rights thereunder in so far as it covers the West half (W $\frac{1}{2}$) of the southeast quarter (SE $\frac{1}{4}$) of Section thirty-four (34) Township nineteen north (19N) Range fourteen east (14E) .80 acres more or less
