

Assignment of Oil and Gas Lease No. 409

WHEREAS, On the 20th day of November 19 22, a certain oil and gas mining lease was made and entered into by and between David H. Vire and Ella Jane Vire, his wife of Tulsa, Oklahoma, Lessor, and Sam Kornfeld of Tulsa, Oklahoma, Lessee, covering the following described land in the County of Tulsa and State of Oklahoma, to-wit:

Said lease being recorded in the office of the Register of Deeds in and for said County in Book 427, page 492, and, WHEREAS, The said lease and all rights thereunder or incident thereto are now owned by Sam Kornfeld

NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell, transfer, assign and convey unto Emile Offenbacher, an undivided seven-eighths (7/8) of the seven-eighths (7/8) working interest of the right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the above described land. It is understood by the parties hereto that the interest assigned by the assignor herein is an undivided forty-nine sixty-fourths (49/64) in the whole lease.

And for the same consideration, the undersigned for himself and his heirs, successors and assigns, do covenant with the said assignee, his heirs, successors or assigns, that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
