

WHEREAS, On the 20th day of November 1922, a certain oil and gas mining lease was made and entered into by and between Ralssa F. Morley and Augusta M. Morley, his wife, of Tulsa, Oklahoma, Lessor, and Sam Kornfeld of Tulsa, Oklahoma, Lessee, covering the following described land in the County of Tulsa and State of Oklahoma, to-wit:

It is understood by the parties hereto that the interest assigned by the assignor herein is an undivided forty-nine sixty-fourths (49/64) in the whole lease

together with all personal property used or obtained in connection therewith to Emile Offenbacher and his heirs, successors and assigns.

And for the same consideration, the undersigned for himself and his heirs, successors and assigns, that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due are payable thereunder have been duly paid.
