Assignment of Oil and Gas Lease No. 409

WHEREAS, On the 15th day of August 1922, a certain oil and gas mining lease was made and entered into by and between W. R. McKee and Cora B. McKee, his wife, of Tulsa, Oklahoma, Lessor, S. and W. J. Flesher, Lessee, covering the following described land in the County of Tulsa and State of Oklahoma, to-wit:

Lot Four (4) of Section Twelve (12), Township Eighteen (18) North, Range Twelve (12) East, except Twenty (20) acres off the West side of said lot Four which is retained by the Pyramid Petroleum Company.

WHEREAS, The said lease and all rights thereunder or incident thereto are now owned by D. M. Elliott insofar as it covers an undivided one-half interest

NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell, transfer, assign and convey unto FLESHER PETROLEUM COMPANY

all of her right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the above described land

together with all personal property used or obtained in connection therewith to Flesher Petroleum Company, including all oil run to the pipe line Company after April fifteenth (15), 1923.

And for the same consideration, the undersigned for her and her heirs, successors and assigns, representatives do hereby covenant with the said assignee, its heirs, successors or assigns, that she is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due an payable thereunder have been duly paid.
