

Assignment of Oil and Gas Lease No. 409

WHEREAS, On the 19th day of January, 1923, a certain oil and gas mining lease was made and entered into by and between George M. Janeway, Lessor, and L. Wheeler and L. P. Wheeler, Lessee, covering the following described land in the County of Tulsa and State of Oklahoma, to-wit:

The Southeast quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Twenty six, Township Twenty one (21) North of Range Thirteen East.

Said lease being recorded in the office of the Register of Deeds in and for said County in Book 426, page 592, and, WHEREAS, The said lease and all rights thereunder or incident thereto are now owned by Bert Swift, the undersigned, to the extent of an undivided one fourth interest in said lease NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell, transfer, assign and convey unto B. B. Rhodes all of his right, title and interest of the original lease and present owner in and to the said lease and rights thereunder in so far as it covers the said undivided interest covering the above described tract of land together with all personal property used or obtained in connection therewith to B. B. Rhodes and his heirs, successors and assigns. And for the same consideration, the undersigned for himself and his heirs, successors and representatives, do covenant with the said assignee, his heirs, successors or assigns, that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
