

Assignment of Oil and Gas Lease No. 409

WHEREAS, On the 11th day of May, 1921, a certain oil and gas mining lease was made and entered into by and between Charles L. Brown and Pearl Brown, Lessor, S and Waite Phillips, Phillips Hawkeye Drilling Company and Fred Stubbs, Lessee, covering the following described land in the County of Tulsa and State of Oklahoma, to-wit:

NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner, of the said lease and all rights thereunder or incident thereto, do SS hereby bargain, sell, transfer, assign and convey unto Fred A. Stubbs, an undivided 5/8ths interest

of right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the above described lands

a like undivided interest in and to together with all personal property used or obtained in connection therewith to Fred A. Stubbs

And for the same consideration, the undersigned for itself and its heirs, successors and assigns, do SS covenant with the said assignee, his heirs, successors or assigns, that it is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due an payable thereunder have been duly paid.
