

Assignment of Oil and Gas Lease No. 409

WHEREAS, On the 30th day of January 1922, a certain oil and gas mining lease was made and entered into by and between Margaret Rentie, a single woman

and Edward Yoder

covering the following described land in the County of Tulsa and State of Oklahoma, to-wit:

The West Half (W $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) and the West thirty-five (35) acres of the East Half (E $\frac{1}{2}$) of the Northwest (NW $\frac{1}{4}$) Quarter, excepting five (5) acres in the Southwest corner of said tract around a well owned by the Gypsy Oil Co. Section Sixteen (16), Township Eighteen (18N) North, Range Thirteen East (13E) containing one hundred ten (110) acres, more or less.

WHEREAS, The said lease and all rights thereunder or incident thereto are now owned by Harold Sparks or H. A. Sparks, in so far as it covers eight ninety sixths (8/96)

NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell, transfer, assign and convey unto E. F. Black, eight ninety sixth (8/96)

of all right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the above described property

together with all personal property used or obtained in connection therewith to

E. F. Black

and his heirs, successors and assigns.

And for the same consideration, the undersigned for himself and his heirs, successors and representatives, do hereby covenant with the said assignee, his heirs, successors or assigns, that he the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
