Range 13 E. of his right, title and interest of the original lessee and present owner in and to the said lease and rights thereunder in so far as it covers the Above described property.

And for the same consideration, the undersigned for J. E. Haas and his heirs, successors and representatives do covenant with the said assignee, his heirs, successors or assigns, that W. T. Jones the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and incumbrances, and that all rentals and royalties due an payable thereunder have been duly paid.
