said parties of the first part, in consideration of the sum of FIVE HUNDRED DOLLARS (\$500.00), the receipt whereof is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns, all of the following described real estate situate in the County of Tulsa, State of Oklahoma, to-wit:
