A G R E E M E N T.

THIS INDENTURE, Made and entered into this 29th. day of April, 1922, by and between HOGUE OIL & REFINING CORPORATION, party of the first part and FRANK L BUSKEY of Plattsburg, Clinton County, New York, parties of the second part.

WITNESSETH: THAT, WHEREAS? the party of the first part is the owner of valid existing and indefeasible oil and gas mining leases free and clear of all lien incumbrances, except a mortgage upon which there is due \$1600.00, except a second mortgage of \$1000 & a third of \$4200.00, which lease is dated July 21st., 1921, executed by Citizens State Oil & Gas Co., and B. Jack Oil Co. and recorded in Book 364, Page 113, and recorded in record 364, at page 112 of the records of the County Clerk of Tulsa County, Oklahoma, covering the following described property, located in Tulsa County, Oklahoma, to-wit:

The Southeast Quarter of the Southeast Quarter of Section 20, Township 11 North of Range 12, East of the Indian Base and Meridian according to the Government Survey thereof and the Northeast Quarter of the Southeast Quarter of said Section 20, Township 19 North, Range 12 East of said County and State.
