ORDER

This matter coming on to be heard on the petition of Vera Stickle for the approval of the deeds of two full blood Creek Indians. And there now appearing James H. Sykes of Tulsa, Oklahoma, attorney for Vera Stickle, and there also appearing Honorable Peter Deichman, United States Probate Attorney:

And the Court, on submission of the deeds and the evidence finds: That Coley Wildcat is a full blood Creek Indian, enrolled upon the final citizenship rolls of the Creek Nation, opposite Roll No. 8104; and that Coley Wildca⁺ was enrolled under the name of Coahlalotuney. That Josie Wildcat is a full blood Creek Indian, enrolled upon the final citizenship rolls of the Creek Nation, opposite Roll No. 8105; and that Josie Wildcat is enrolled on said rolls as Yarcharney. That Ka-la-wee was a full blood Creek Indian enrolled upon the final rolls of the Creek Nation opposite Roll No. 8848. That Ka-la-we^e died on the 1st day of July, 1901, in that portion of the Creek Nation now embraced with in the boundaries of Creek County, State of Oklahoma; and that the County Court of Creek County, State of Oklahoma, has jurisdiction of the deceased allottee's estate. That there was allotted to Ka-la-wee as a portion of her allotment, the

> South Half of the South Half of the Southwest Quarter of the Northeast Quarter, of Section 32 Township 19 North. Range 12 East of the Indian Base and Meridian, in Creek County, Oklahoma, and containg 10 acres, according to the United States Survey thereof.

That on the 10th day of June, 1916, Coley Wildcat made a warranty deed to the petitioner, Vera Stickle, covering the lands herein described. That on the 10th day of June, 1916, Josie Wildcat made a warranty deed to the petitioner, Vera Stickle, covering the land described herein. That Josie Wildcat and Coley Wildcat were paid in full for any right, title, or interest they may have had in or the <u>the</u> lands above described. That said deeds were fairly made and legally executed, and that the same should be approved in accordance with the Act of Congress of May 27th, 1908, conferring the jurisdiction on this Court to approve deeds of full blood Indians.

IT IS THEREFORE, Ordered, adjudged, and decreed that the deed of Josie Wildcat made, executed, and delivered on the 10th day of June, 1916 to Vera Stickle covering the land
