206573 LB COMPARED FARM RENTAL CONTRACT

THIS AGREEMENT, Made and entered into this 15th day of August, 1922 by and between David Haikey of Tulsa County, party of the first part, and Bert Davis of Tulsa County, party of the second part.

WITNESSETH, That for and in consideration of the covenants and agreements hereinafter made, the party of the first part has let, leased and demised, and does by these presents let, lease, and demise unto the party of the second part, for Agricultural purposes, for the terms of One year from and after the First day of January, 1923. the following described tract of land lying in Tulsa County, state of Oklahoma:

This land is known as the David Haikey allotment, in Section 30,
Tpn. 18, Range 14, thirty acres out of the homestead, this being
the 30 acres out of the 40 acre tract of which ten acres was sold
to a John Brown.

The said party of the second part, for the use of said land, agrees to pay to the party of the first part, as rent the sum of One Hundred Dollars (\$100.00) on the 15th day of August, 1922 DOLLARS and Seventy-Five Dollars on the 20th day of December, 1922. per annum during the term of this contract, payable as follows;
