That for and in consideration of the sum of Two Hundred and Fifty and no/100 Dollars
(\$250.00), to them in hand paid, the receipt whereof is hereby acknowledged, FROM funds
derived from oil royalties from restricted land allotted to said Nettie Harjo.

THE SAME BEING FUNDS HELD BY THE UNITED STATES IN TRUST, SUBJECT TO DISBURSEMENT UNDER
THE SUPERVISION OF THE SECRETARY OF THE INTERIOR, said grantors have granted, bargained,
sold and conveyed unto the said Nettie Harjo grantee, and by these presents do hereby
grant, bargain, sell and convey unto the said Nettie Harjo, grantee the following de-
scribed real property and premises situated in Tulsa County, State of Oklahoma, to-wit:

The South Half (S/2) of Lot Two (2) in Block Twenty-five (25), in the
Town of Red Fork, according to the official and approved plat thereof.

together with all the improvements thereon, and appurtenances thereunto belonging, and
warrant the title to the same.

TO HAVE AND TO HOLD said described premises, unto the said grantee, her heirs and
assigns, forever, free and clear and discharged of all former grants, charges, taxes,
judgments, mortgages, and other liens and incumbrances of whatsoever nature, subject
to the condition that no lease, deed, mortgage, power of attorney, contract to sell,
or other instrument affecting the land herein described or the title thereto, executed
during the lifetime of said grantee at any time prior to April 26, 1931, shall be of
any force and effect or capable of confirmation or ratification, UNLESS MADE WITH THE
