DECLARATION OF TRUST

and the second of the second of

J. M. Wolford, of Iola, Allen County, Kansas, hereby transfers, makes over, assigns and conveys to J. M. Wolford as Trustee, all his interest in and to a cartain copy-right upon a book or story entitled. The Kentucky and West Virginia Feud, being the entire whole interest in the same.

The said J. M. Wolford, as Trustee, hereby accepts said transfer, assignment and conveyance in trust upon the following terms, to-wit:

Hereby a trust is created under the terms of Chapter 16, Session Laws of 1919 of the State of Oklahoma, entitled

"An Act supplemental to and amendatory of Article Four, Chapter 65, Revised Laws of Öklahoma, 1910, ets."

Said Trust estate shall be known as "Blue Ridge Film Company" and its principle business to be conducted at 319 Security Building, Tulsa, Oklahoma, or such other place or place as the Trustee or Trustees shall by resolution determine, for the term of twenty-one years unless sooner would up hereunder.

Said Trustee or the majority of the Trustees jointly if any other one or more are added hereto, shall have the power to conduct a business in said name anywherein the State of Oklahoma or the United States or Foreign countries, Said business shall consist of writing seenarios, directing and making moving pictures, and producing and marketing films either by rental or exhibiting or owning or operating theatres, or doing any other things, necessary for the proper production of moving pictures, with full power of delegation, substitution or addition.

For said purposes or any of them said estate and said trustee or trustees for it are empowered to receive title to, hold, buy, sell, exchange, transfer and convey such real and personal property or either as they deem best suited to their said business; and to take, receive, invest and disburse the receipts, earnings, rents, profits or returns of said estate; to receive title, to, hold, buy, sell, exchange, transfer, assign, contract for and in any lawful way acquire or dispose of any stock, bond, certificates of indebtedness, interest in or property of any corporation, association, joint stock association, trust estate, partnership or business appurtenant to or doing the business of any part or all of the kinds of business which this estate is empowered to transact. To execute such notes, bonds, mortgages or other evidence of debt as may be useful to the progress of the estate. Said trustee may designate an additional trustee or trustees by designation in writing duly acknowledged and filed for record in Tulsa, County, Oklahoma.

Succession in estate to said trustee hereby designated or provided for shall be by amendment hereto or written designation thereof or in case of this death without such designation then by order of any district court of Oklahoma sitting for the county where any of the tangible property of the estate shall be situated.

The provision of section 4 of said act enabling this estate is hereby accepted and applied, to-wit: liability to third persons for any act, omission, or obligation of a trustee or trustees of this trust, when acting in such capacity, shall extend to the whole of the trust estate held by such trustee, or trustees, or so much thereof as may be necessary to discharge such liability but no personal liability shall attach to the trustee or the beneficiaries of such trust for any such act, omissinn or liability.
