207491 LB COMPARE LEASE

THIS LEASE, made and entered into this 27th day of June 1922, by and between Homer Perryman of Tulsa Oklahoma, hereinafter called the lessor, and Charles Kenneth Posey, a minor, for whom Andy W. Posey is now guardian, of Tulsa, Oklahoma, hereinafter called the lessee, WITNESSETH:

1. That the lessor owns the following described real estate and premises, situated in Tulsa County, Oklahoma, to-wit:

Northwest Quarter (NW $\frac{1}{4}$) of Southeast Quarter (SE $\frac{1}{4}$) of Section 7, Township 18 North, Range 13 East,

2. That the lessor, in consideration of the covenants, promises and agreements herein contained and expressed, hereby rents, leases and lets to the lessee, the above described premises, to have and to hold the same from 1st day of January 1923, to the 1st day of January 1924, together with the buildings and improvements thereon, for agricultural purposes.

3. That the lessor covenants to place the lessee in the quiet and peaceable possession of said premises on or before the beginning of the term covered by this lease, and to protect the lessee in the quiet and peaceable possession of said premises during the term of this lease.

4. That the lessee promises and agrees to pay to the lessor as rental for said premises for said term, the sum of One Hundred (\$100.00) DOLLARS payable as follows: all cash in hand paid, the receipt of which is hereby acknowledged by the lessor.

5. That no part of said rent money shall be due and payable until the lessee shall have been placed in the quiet and actual possession of said premises.

6. That the lessee shall have the right to make such improvements as he shall desire and lessor shall pay lessee for the same as such price as shall be agreed upon by them and in case of a disagreement the same shall be settled by arbitration, such payment or settlement to be made at the end of the term of this lease. That there is no valid, existing agricultural lease covering said premises at this time.
