Beginning at a point on the West line of Lot 24, Block 2, Orchard Addition, 3.5 feet South of the North line of said lot; thence running Southeasterly to a point 43 feet East of the Southeast corner of Lot 24, Block 2, Orchard Addition, Tulsa, Oklahoma, according to the duly recorded plat thereof.
