

(19) North, Range Twelve (12) East of the Indian Base and Meridian, Tulsa County, Oklahoma, containing Thirty-one and 61/100ths (31.61) acres, more or less, according to the U. S. Government survey thereof.

Also, all of the following described real estate, situated in the County of Tulsa and State of Oklahoma, to-wit: All that portion of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Fourteen (14), Township Nineteen (19) North, Range Twelve (12) East, lying south and east of the Midland Valley Railroad right of way, containing Eight-tenths (8/10ths) of an acre, more or less; and all that portion of Lot Six (6), in Section Thirteen (13), Township Nineteen (19) North, Range Twelve (12) East, lying south of the Midland Valley Railroad right of way, containing Seven and 92/100ths (7.92) acres, more or less.

ITEM 4. Lots Twenty-one (21), Twenty-two (22), Twenty-three (23) and Twenty-four (24) in Block Eight (8) in Thomas Addition to the City of Okmulgee, County of Okmulgee, State of Oklahoma.

ITEM 5. Lots One (1) and Two (2) in Block Fifty-three (53) in the City of Okmulgee, County of Okmulgee and State of Oklahoma.

ITEM 6. All that portion of Lot Three (3) in Block Fifty-three (53) of the original Town of Okmulgee, in Okmulgee County, State of Oklahoma, bounded and described as follows, to-wit:

Beginning at a point One Hundred and Sixty (160) feet West of the Southeast corner of said Block Fifty-three (53), thence North One Hundred and Forty (140) feet to a point; thence West along the Southern line of the alley intersecting said Block Fifty-three (53) approximately sixty-four and 8/10ths (64.8) feet to a point upon the Western boundary line of said Block Fifty-three (53); thence in a Southerly direction along the Western boundary line of said Block Approximately One Hundred and Forty (140) feet to a point upon the Southern boundary line of said Block; thence East along the said Southern boundary line of said Block, approximately sixty-two and 9/10ths (62.9) feet to the place of beginning, according to the official plat of said Town, approved by the Secretary of the Interior on the Sixth day of November, 1901, and of record and on file in the office of the Register of Deeds of Okmulgee County, Oklahoma.

ITEM 7. Part of Lots Three (3) and Four (4) in Block Fifty-three (53) in the City of Okmulgee, County of Okmulgee and State of Oklahoma, more particularly described as follows:

Beginning at the Southeast corner of said Block Fifty-three (53), running thence West One Hundred Forty (140) feet, thence North Seventy-five (75) feet, thence East One Hundred Forty (140) feet, thence South Seventy-five (75) feet to the place of beginning.

ITEM 8. Part of Lots Three (3) and Four (4) in Block Fifty-three (53) in the City of Okmulgee, County of Okmulgee and State of Oklahoma, more particularly described as follows:

Beginning at a point seventy-five (75) feet North of the Southeast corner of said Block Fifty-three (53), thence running North Seventy-five (75) feet, thence West One Hundred Forty (140) feet, thence South Seventy-five (75) feet, thence East
