OKLAHOMA MORTGAGE

THIS INDENTURE, ^{COMPARED} Made this 1st day of July in the year of our Lord One Thousand Nine Hundred twenty-two by and between The Tulsa Stone Company, a corporation organized and existing under the laws of the State of Oklahoma of the County of Tulsa and State of Oklahoma, party of the first part, and Southern Surety Company a corporation, organized and existing under the laws of the State of Iowa, party of the second part:

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Fifty Thousand and no/100 (\$50,000.00) Dollars, to it in hand paid, by the said party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained and sold, and by these presents does grant, bargain, sell, convey and confirm unto said party of the second part, and to its successors and assigns, forever, all of the following described tract, piece or parcel of land lying and situate in the County of Tulsa and State of Oklahoma, to-wit:

All that part of the Southwest one-fourth (SW/4) of the Northwest one-fourth (NW/4) of Section Twenty-eight (28), Township Twenty (20) North, Range Fourteen (14) East of the Indian Base and Meridian, lying South of the St. Louis and San Francisco Railroad right of way, and the quarry thereon situated -----

containing -----acres, more or less, according to the government survey thereof.

TO HAVE AND TO HOLD THE SAME, with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and all rights of homestead exemption unto the said party of the second part, and to its successors and assigns forever.
