AGREEMENT, Made and entered into the 5th day of July 1922, by and between James H. Wilson and Vesta E. Wilson husband and wife of -----hereinafter called lessor (whether one or more), and J. M. Pennington and C. F. Cornett hereinafter called lessee:

WITNESSETH: That the said lessor, for and in consideration of One Dollars, cash in hand paid, the receipt of which is hereby acknowledge, and of the covenants and agreements hereinafter contained on part of lessee to be paid, kept and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said lessee for the sole and only purpose of mining and operating for oil and gas and of laying of pipe lines, and of building tanks, powers, stations and structures thereon to produce, save and take care of said products, all that certain tract of land situate in the County of Tulsa State of Okla. described as follows, to-wit: The North half (N. 1/2) of the South West Quarter (SW 1/4) of Section Twenty Seven (S. 27) Township Nineteen (T. 19) North Range Fourteen East (N.R. 14E.)
