THIS AGREEMENT, made this 20th day of July, 1922, between the INDEPENDENT PACKING COMPANY, a corporation, of Tulsa, Oklahoma, party of the first part, and H. H. SNIDER, of Tulsa, Oklahoma, party of the second part, WITNESSETH:

That the party of the first part for and in consideration of the covenants, agreements, stipulations and rentals hereinafter set out, and agreed to be paid, kept and performed by the part of the second part, has demised, leased and let, and by these presents does demise, lease and let unto the party of the second part, the following premises situate in Tulsa County, and State of Oklahoma, to-wit:

All of the West one-half of the Southeast Quarter of the Northwest Quarter of the Southeast quarter of the Northwest quarter; and all that part of the West one-half of the Northeast Quarter of the southwest Quarter of the Southeast quarter of the Northwest Quarter, lying North of the North line of the right of way of the M. K. & T. Ry.
