A strip of ground, not to exceed ten (10) feet in width on either side of the center line ofsaid sewer line, as shown by the blue prints on file in the City engineer's office of the City of Tulsa, the center line of said Twenty (20) foot strip, being more particularly described as follows, to-wit:

Beginning at a point on the West line of Lot 15, Central rlace Addition, a distance of 15.3 feet from the Southwest corner of said lot: thence Southeasterly across said lot to a point on the South line, a distance of 42.0 feet from the Southwest corner of said lot.
