COMPARED KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, the owner of the legal and equitable title to the following described real estate, situated in the City of Tulsa, Tulsa County, State of Oklahoma, for and in consideration of the sum of One Dollar (\$1.00) cash in hand . paid by the City of Tulsa, Uklahoma, and other good and valuable considerations, receipt of which are hereby acknowledged, do hereby grant and convey unto the said City of Tulsa, Uklahoma, a perpetual easement, through, over, under and across the following described property, situated in said City, to-wit:

A strip of ground, not to exceed ten (10) feet in width on either side of the center line of said sewer line, as shown by the blue prints on file in the City Engineer's office of the City of Tulsa , the center line of said Twenty (20) foot strip, being more particularly described as follows, to-wit:

> Beginning at a point on the West line of Lot 29, Central Place Addition a distance of 43.3 feet from the Southwest corner of said lot; thence South easterly across the South one-half of the West 108.5 feet of

said lot to a point on the East line, a distance of 4.4 feet from the Southeast corner of the South one-half of the West 108.5 feet of Lot 29. Central Place Addition
