## MAY PROVIDE SALARIES.

The trustees may provide for the payment of salaries, wages, fees and commissions to the officers, clerks, agents and other employees of the Association, including the trustee or trustees. The trustee or trustees, as compongation in connection with the Association, shall be entitled to receive twenty-five per centum (25%) of the profits arising from the operations of the Association.

## A SINGLE TRUSTEE.

Wherever the word " trustees " appears in this Declaration, it shall be taken to mean the sole trustee at such times, if any, when there shall be but one trustee.
