The undersigned, W. E. Davis, of lawful age, being first duly sworn, deposes and states:

That he elsewhere certified that he accurately surveyed and staked as required by law, the Greenlawn Addition to Tulsa, Oklahoma, which said certificate is true, and that the said tract is:

All of Lots One (1) and two (2), in Section three (3), Township Nineteen (19), Range thirteen (13) East of the E. M. , Tulsa, County, Oklahoma;

That Lot one (1) is in the North Half (N $\frac{1}{2}$) of the Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) and that Lot two (2) is in the North half of the Northwest Quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section three (3), of said township and range.

That in the recorded plat of the said addition "Greenlawn Addition", Block Two (2) covers the original Lot one (1) of the Government survey, and that Block One (1) Covers Lot two (2) of the Government survey; that Lot One (1) is the most easterly of the two lots and that Lot two (2) is the most westerly of the two lots, as shown on the recorded plat of said Greenlawn Addition to the City of Tulsa, while Block two (2) is the most easterly of the two blocks, and Block One (1) is the most westerly of the two blocks, as shown in the part of the plat which shows the staking of the town lots.
